Virtual Event Regulations

- 1. I understand that virtual event is an event that can be completed from any location utilizing a running app. I recognize the importance of physical activities for our health (physically and mentally), and participating in these virtual events could be beneficial. I understand that all the virtual events are organized and operated following all applicable laws, and I agree to participate in the event while taking in all possible measures against infection.
- 2. I agree to use safe pedestrian practices when on streets and roadways, while being observant and aware of my surrounding and other people.
- 3. I agree to participate in the event based on my personal preference and capability, and acknowledge that I am responsible for monitoring my health. I also understand that there is no medical or aid station (fluid and food) arranged or provided by the event organizer.
- 4. I agree that event organizer will not be held responsible in the case of illness (including communicable disease), accident, incident that are not held accountable to the organizer.
- 5. I agree that the entry will not defer to a different event in the case of event cancellation due to a reason not held accountable to the organizer.
- 6. Virtual event is based on GPS tracking and geofence. In order to collect accurate data, I agree to follow the following guidelines:
- 6-1. App required for the event varies by the event. Please read the Event Regulation carefully.
- 6-2. Event organizer will not collect nor accept any data collected by an app that is not specified in the event.
- 6-3. Individual device used in the event must be connected to the app, however, the process may differ depending on the type and/or model of the devices, and it is sole responsibility of the participant to contact the appropriate help desk of the app and not the event organizer.
- 6-4. All collected data and personal information will be handled accordingly to the Privacy Policy of the event organizer.
- 6-5. Event organizer will not be held accountable for failure to collect accurate data due to malfunction of the personal device.
- 6-6. If cheating (proxy runner, use of exercise equipment, automobile, etc.) is discovered, the runner will be disqualified and hence with, the record, award and such will be eliminated.
- 6-7. Please be cautious of your surroundings while using GPS equipped devices or phone.
- 7. I acknowledge that medical attention will not be provided by the event organizer for the virtual event. I agree that I will participate in the event only if I am physically fit, healthy, and sufficiently trained, and monitor my health while taking in advice from health professional.
- 8. If it is a virtual event that utilizes physical venues or area, I agree to follow the following:

- 8-1. I agree to cooperate with body temperature check. If the temperature is above 37.5 Celsius, I will follow the staff instruction and withdraw from the event.
- 8-2. I agree to follow medical orders of the medical staff stationed within the venue/area. I acknowledge that medical professional providing medical care may be an opposite sex and that I may have to provide medical record to a third-party healthcare if I am transported to a different medical facility.
- 8-3. If it is determined unsafe, the event organizer and/or the medical professional has the right to make the decision to withdraw the participant from the event.
- 8-4. I agree to follow instructions of the event staff that is based on guideline to deliver safe event (failure to comply may result in disqualification and/or record erased).
- 9. I agree that I cannot transfer the Award I received in the virtual event to a third party.
- 10. I agree that copyright of images, films, photographs, articles, coverage of the event, and the usage right for TV broadcasting, newspapers, magazines, and the Internet, belongs to the event organizer.
- 11. I agree that event organizer has the right to change these terms and conditions at any time without prior notice. In the event with any changes involved, the revised terms and conditions shall be active from when it is posted on the website and email notification are sent to the registered address.
- 12. All disputes in regards to participation in the virtual event, shall be submitted to the exclusive jurisdiction of the Tokyo District Court in the first instance.

Entry Regulation

- 1. False name, date of birth, sex, nationality, residing address are strictly prohibited. Please carefully check your registered information for they are not allowed to be changed or canceled after submission.
- 2. Proxy registration and/or multiple entry is not allowed.
- 3. If under the age of 18, the entrant must receive waiver from a parent or legal guardian.
- 4. The event organizer will not be held accountable for an event due to poor internet connectivity, malfunction of personal device, browser setting, or operating system (OS).
- 5. Email delivery check for the registered email address will not be conducted. Note, the organizer will not be responsible for any inconvenience or loss due to trouble with the device (malfunction), system/email setting, failure to receive email or change in email address.
- 6. The Help Desk or the event organizer will not respond to any inquiry related to number of entries received.
- 7. Promotional campaign or advertisement through the event not approved by the organizer

is not allowed. If discovered, entry will become void with no refund of the entry fee.

- 8. Entry fee will not be refunded with no exceptions for double/over payment, withdrawal from an event due to personal reason, and/or unable to participate in the event due to weather or natural disaster. Also note, the entry will not be allowed to transfer or defer to a different event.
- 9. The event organizer, in recognition of the importance of protecting personal data, abides by all laws and ordinances concerning the protection of personal data and adheres to the event organizer's privacy policy when handling personal data.
- 10. Personal information will be used to deliver necessary information related to the event, including, and not limited to, event detail, record, and promotion from related third-party. In the interest to enhance the future events of the organizer, it may also be used for promotional and/or marketing purposes.
